INFRASTRUCTURE IMPROVEMENT PROJECT

Our community had a successful 2013 with the completion of our Clubhouse renovation project and the beginnings of the Forest Hill Infrastructure project. Four significant construction projects are, or soon will be, underway in Forest Hill, each of which will which will cause some inconvenience, but add to the neighborhood's safety and quality.

- 1. The Dewey Circle Traffic calming project has just been completed, and is already reducing speeding and making the pedestrian crosswalks much safer
- 2. The Dewey Corridor Traffic Calming Project, approved by SFMTA in December, will install islands and traffic cushions along Magellan, Pacheco, 9th Avenue Taraval and Dewey. There will be a new traffic circle at Dewey and Pacheco.
- 3. PG&E is about to drill test holes for new streetlight wiring in the area along and below Pacheco street, from Dewey to 9th Avenue. Trenching for the Installation of new wiring will begin in the spring and may involve

digging up streets and/or sidewalks. Some of the light poles will be replaced and we are asking that eight additional ones be installed to cover areas that are now poorly lit. Residents will receive notice prior to each phase of the work.

DPW is preparing to repave the portions of 4 San Marcos and Santa Rita Avenues from Mesa and Castenada to the end of the cul-desac.. They will also repair and rebuild the failing portions of the retaining wall on San Marcos and replace the chronically damaged pipe rail fencing. The stairways that cross the median are in poor condition and will be repaired as well. Two large trees in the median have been posted for removal in the areas where the wall has been weakened. Tree removal, stairway and retaining wall work will occur in the spring and summer; paving and gutter/curb repair is expected next Fall or Winter. Residents will receive notice before each phase of the work.

The infrastructure Committee and the Board of Directors are working with the various agencies involved in these projects to achieve the best possible results and consistent inter-agency coordination, but many details of both the lighting project and the street/median strip repairs remain to be determined. Minutes of the Jan 9th Community meeting, with details about the latter two projects, have been sent to our e-mail list and are posted on the Forest Hill website.

TREES & LANDSCAPES

The FHA contracts with Valley Crest to assist in the maintenance of trees and shrubs on our sidewalk and median strips. Valley Crest provides weekly landscape maintenance of the Clubhouse and Pacheco triangle, a seasonal pruning and weed control program of sidewalk landscape strips and planted median islands, and irrigation management of all automated irrigation systems on medians, islands and Clubhouse landscapes.

Summer and winter pruning of trees following FHA approval is limited to pruning necessary to meet structural, liability and clearance needs of the tree and site, while maintaining the tree's natural form. Pruning occurs after the proposal is posted on our website for 14 days to allow for homeowner comment.

Our tree removal program, as defined by the City, is limited to trees that are dead or infested without likelihood of improvement. Every tree that is removed must be replaced as per San Francisco guidance; the FHA pays to remove and to replace trees (15 gal container size). We obtain the necessary City tree removal permit on behalf of homeowners.

Please note that homeowners are responsible for sidewalk and curb repairs. Please see details of the Valley Crest agreement on our website.
