AirBnB Rentals in Forest Hill

The advent of AirBnB has been the subject of ample discussion in city government here and in many other cities around the country as it has affected both the hotel industry and the way in which homeowners use their property. In Forest Hill, some homeowners have used this company as a way to offer short-term rentals of bedrooms in their homes. There are also homes which are no longer family residences, but now are used exclusively as short-term rentals, almost as hotels. These are sometimes rented out to multiple unrelated individuals, bringing multiple vehicles to the house and street.


On some occasions the homes have served as party houses, resulting in noise, raucous drinking and other disturbances. Some residents have asked that AirBnB be banned completely in Forest Hill, while others viewed it as a positive opportunity for individual homeowners. The board had a long discussion of the challenges

brought by this new service and will seek legal advice before taking any action on the question.

Change in Clubhouse Rental Policy

At the October 12th board meeting, the board of directors voted to immediately cease rental of the Clubhouse to people who are not members of the Forest Hill Association and, to the extent possible, cancel any such rentals, which have been contracted already. This action was taken after a Cease and Desist Order from the Planning Commission, which the Association was contesting. But was also in

response to growing community concerns about the impact that such rentals have caused, through traffic, crowds, and noise, and through reduced availability of the Clubhouse for community events.

REMEMBER TIM TREACY

Our neighbor Tim Treacy passed away peacefully on October 5, 2015, at the age 83.

Tim, a third-generation San Franciscan, was a Director of the Forest Hill Association for 19 years, and its President for 14 of those years. Tim grew up in his family's home on Dewey Boulevard and later bought his own home on Linares Avenue. He attended St. Ignatius Preparatory School, Stanford University, and Stanford Law School, and was admitted to the State Bar of California in 1958. After maintaining a successful private law practice, Tim joined the State of California Public Utilities Commission, where he rose to be its principal counsel, specializing in telecommunications law, where he argued cases before the California Supreme Court as well as the United States Supreme Court.

A 50-plus year member of the Olympic Club, Tim was a man of many interests, including snow skiing and mountaineering, as part of which he scaled peaks including Kilimanjaro, Denali (Alaska) and Aconcagua (South America).

As a FHA Director, Tim not only worked successfully to abate airplane noise, but also to convince the City and County of San Francisco to acquire Hawk Hill as Open Space. He also convinced CCSF, after a brush fire, to fence off the hillside between Forest Hill and Laguna Honda Boulevard, which had become a notorious "homeless area". He also worked with CCSF to sell an abandoned home on San Marcos Avenue, and ensure that the sale proceeds went to the rightful heir. A strong defender of our Urban Forest, Tim was always willing to assist neighbors with their problems. He will indeed be missed by all of us, most especially by those lucky few who knew him well.

AREA "T" UPDATE

As mentioned in an earlier newsletter, there is a signature gathering campaign underway to get several streets in Forest Hill added to the Area "T" restricted parking zone.

Thus far, more than 50% of the residents on Ventura have signed the petition(s), as have those on Pacheco between 8th and 9th Avenues. Residents are circulating petitions – albeit not rapidly – on the rest of Pacheco Street and Linares Avenue.

We encourage you to sign these petitions **now**. This is because, as more areas become restricted, the pressure of commuter and RV parking on the remaining unrestricted areas will increase. The choice is to sign now, or to have to sign later, after curb parking on your street is overloaded every workday.

There are downsides to having Area "T" restrictions: you must either purchase a sticker (\$100+/year) or park in front of your driveway (no sticker required). Your daytime guests (8 A.M. – 3 P.M) might be ticketed if they stay over 2 hours. Traffic on your street may increase, and may traffic speed, since there will be fewer cars parked on it.

Note that SFMTA has a traffic calming plan for Forest Hill. The first step in this plan was scheduled at a public hearing on September 4th: Bulb-outs next to the Forest Hill pillars at 9th and Pacheco.

If you have not been offered a petition to sign, you can download one by Googling "Restricted Parking Permit" which will point you to the SFMTA document. Notify jwearhart17@gmail.com to arrange pick-up of your signed petition.
